#### **Victorian Accounts**

Harry Moyle presented his Financial Report for the year ended 30 June 2022 as follows:

OTU Vic has ended the 2021/22 year in a sound financial position with net assets of \$29,578 after incurring a modest deficit on activities of \$1,671.64.

Activities started to return to pre-pandemic levels with monthly lunches occurring regularly again, and the return of the Geddes Dinner, and a well-attended ANZAC Day lunch.

Cash at bank amounted to \$33,944.30 at year end.

Thank you to all those Victorian members who have resumed meeting with their fellow Scheyvillians and maintaining the objectives and traditions of the Association.

Income consisted of \$3460 from the National Rebate, and \$10.53 in interest from the ANZ Bank.
